Director of Maintenance

• Announced will be looking after AC and Appliances and looking forward to meeting everyone and thanks for allowing me to help out.

Director of Public Relations

- Would like to speak about vacation rentals as I received feedback about my LOTG article over summarized. To be clear Gulf Harbors is not a vacation rental community. In order to be a vacation rental community would many steps taken before that could happen.
- Vacation Rental is defined as a home rented for less than 30 days more then three times per year.
- If renters cause an issue call the Sheriffs department. Street parking, late night noises you need to report to the Sheriffs department.

President

- Announced insurance last year in 2022 cost \$9800.00 including wind and \$3200.00 for liability. We budgeted for 2023 \$13000 including wind and \$3500.0 for liability. Two weeks prior to renewal date received a letter from our current insurance carrier that they will not renew due to underwriting reasons and proximity to the water.
- Had put it out in the community for recommendations on carriers. One company pulled their quote. We are down to two choices.
- First choice is CRC Group property with wind \$25,496.00 no flood, \$21,373.00 of that is for wind only. They are valuing the building at \$843,000 and contents at \$110,000.00. Deductible \$2500.00 if not related to wind. If wind related it is 3%, \$10,000.00 for a named storm.
- Announced did not see that much exposure to wind damage, asked of the members. Currently have a new roof and hurricane shutters.
- Without wind could get liability and property insurance somewhere between &7000.00 to \$8000.00 and take the balance of what's allocated and deposit into a newly named hazard fund, and each year continue to deposit funds into the hazard fund.
- Motion was made to only carry liability and basic property insurance for approximately \$9000.00 and place the excess into the hazard fund. Motion seconded. Motion not carried.
- Motion was made to only carry liability and basic property insurance for approximately \$9000.00 and place \$8500.00 into the hazard fund. Motion seconded. Motion carried.
- Motion made to change the name of the flood account to the hazard account. Motion seconded. Motion approved.
- Announced there are some tables still left that we would like to donate if anyone is in need.
- Comment from member- South boat ramp, boards rotting, needs power washing. President stated was unaware will look into it and speak with Frank.
